Attend Annual Legislative Action Conference 2019

Be a powerful voice in Sacramento as a SCSNA sponsored delegate. Building effective alliances with other organizations that share our vision and maintaining a credible presence with elected officials is fundamental to the success of Child Nutrition Programs. As an active member of CSNA and SCSNA, we encourage you to attend the annual Legislative Action Conferences in Sacramento, CA and Washington D.C. in 2019.

State Bills CSNA is Monitoring

Friday, August 31, 2018 was the deadline for legislation to be passed by both houses in final form and sent to Governor Brown. Bills must be approved by the Governor by September 30, 2018, in order to become law next year. A number of bills of interest to CSNA are among those before the Governor, including AB 3178 (Rubio), which the Governor vetoed earlier this week. Below is a more detailed list of the legislation we have been monitoring this year and their current status.

Bills of Interest

<u>AB 1871</u> (Bonta) Charter schools: free and reduced-price meals. Requires a charter school to provide each needy pupil with one nutritionally adequate free or reduced-price meal during each school day. AB 1871 has been sent to the Governor for final action. **CSNA – Support**

<u>AB 1884</u> (Calderon) Solid waste: single-use plastic straws. This bill would prohibit a full-service restaurant from providing single-use plastic straws to consumers unless requested by

the consumer. AB 1884 has been sent to the Governor for final action. *Note: Bill currently does not apply to schools* **CSNA - Watch**

AB 2049 (Gonzalez Fletcher) Classified school employees: duties. Current law requires the governing board of a school district to employ persons for positions not requiring certification qualifications. Current law requires the governing board of a school district to classify those employees and positions and requires that they be known as the classified service. Current law requires the governing board of a school district to fix and prescribe the duties to be performed by all persons in the classified service and other positions not requiring certification qualifications, except as provided. This bill would make nonsubstantive changes to the latter provision. AB 2049 was approved on a 3-2 vote by the Senate Public Employment and Retirement Committee on June 25, 2018. The bill was scheduled to be heard by the Senate Appropriations Committee on August 6, 2018; however, the hearing on the bill was postponed. As the bill did not make it to the Governor by the August 31st deadline, it cannot become law this year. CSNA – Watch DEAD

AB 2261 (Friedman) School employees: merit system: exempt from the classified service: community representatives. Current law requires a school district that adopts a merit system to appoint a personnel commission and requires the commission to classify all employees and positions within the jurisdiction of the governing board of the school district or of the commission, except for specified positions that are exempt from the classified service. Current law requires positions established for the employment of community representatives in advisory or consulting capacities for not more than 90 working days, or a total of 720 hours, in a fiscal year to be exempt from the classified service. This bill would make nonsubstantive changes to the latter provision. AB 2261 was approved by the Governor on September 7, 2018 and becomes law on January 1, 2019 (*Chapter 297, Statutes of 2018*). **CSNA - Watch**

AB 2271 (Quirk-Silva) School food authorities: federal equipment assistance grants: matching state grants. Requires CDE to provide a matching state grant of up to \$100,000 to a school food authority participating in the federal National School Lunch Program that applies for and is awarded a federal Equipment Assistance Grant for School Food Authorities. AB 2271 was approved by the Senate on August 24, 2018 and has been sent to the Governor for final action. CSNA - Watch

<u>AB 2360</u> (Rodriguez) Pupil nutrition: school district and food bank partnerships. This bill requires the California Department of Food and Agriculture, in collaboration with CDE, the Strategic Growth Council, and other relevant entities to be determined to establish guidelines and best practices for food banks and school districts to create partnerships to increase student access to fresh produce items. AB 2360 was approved by the Senate on August 21, 2018. The Assembly concurred in the Senate amendments on August 27, 2018 and the bill has been sent to the Governor for final action. **CSNA – Watch**

<u>AB 3043</u> (Berman) Pupil nutrition: breakfast and lunch programs. Among other things, authorizes a school district, county superintendent of schools, private school, or charter school that participates in the federal School Breakfast Program, commencing with the 2019– 20 school year to provide universal breakfast, to the maximum extent practicable. The bill would define "universal breakfast" to mean a nutritionally adequate breakfast that complies with, and qualifies for reimbursement under, the federal School Breakfast Program and that is provided to every pupil at no charge. AB 3043 was approved by the Senate on August 27, 2018 and the Assembly on August 29, 2018. The bill has been sent to the Governor for final action. **CSNA** – **Support**

AB 3083 (Quirk-Silva) Pupil nutrition: food and beverages: food incentive program. This bill prohibits a school, school district, or charter school that participates in the federal National School Lunch Program or federal School Breakfast Program from participating in a food incentive program that rewards pupils by providing foods or beverages that do not comply with the nutritional standards. AB 3083 failed to pass out of the Assembly by the legislative deadline so it cannot become law this year. **CSNA** –**Support** *DEAD*

AB 3178 (Rubio) Solid waste: recycling: diversion: green material. The California Integrated Waste Management Act of 1989 requires the source reduction and recycling element to divert from disposal 50% of all solid waste subject to the element through source reduction, recycling, and composting activities, with specified exceptions. Current law governs the use of solid waste as alternative daily cover in the construction and operation of a solid waste landfill, including the determination of whether that use and other beneficial reuse of solid waste constitutes diversion through recycling rather than disposal. Current law provides for the department to adopt regulations in this regard. This bill would delete obsolete provisions relating to the adoption of these regulations. AB 3178 was vetoed by the Governor on September 10, 2018. CSNA – Watch DEAD

<u>SCR 104</u> (Hertzberg D) National Nutrition Month. Declares the month of March 2018 as National Nutrition Month and would encourage citizens to seek nutritional education. SCR 104 was approved by both houses and has been chaptered by the Secretary of State. Chapter 40, Statutes of 2018. CSNA – Support

Goal 4: Governance & Operations

Objective – Define specific roles & responsibilities of committees & within committees and Co-chairs.

Strategies:

- 3. Update and share SCSNA Executive Committee job descriptions with membership early in the school year.
- 4. Invite CSNA Leadership and Supervisory Chapter Presidents to SCSNA meetings.



Be a Legislative Advocate (Without going to Sacramento or D.C.)

Have you been affected by legislative actions? Of course, you have! It may be directly or indirectly, but some law at some point has affected each of us. You hire the lawmakers. Learn who they are and begin a relationship.

First - Find Your Legislator:

- Go to http://www.legislature.ca.gov
- Select "Legislators" on the left menu bar
- Search by address, work and residence

Make An Appointment:

- Call your legislator's home office
- Ask for the scheduler, if the person's name is not listed specifically
- Make an appointment to see them for a discussion
- Invite them to come for lunch in your district
- Legislators are typically in their local district on Fridays

Put Together Your Message:

- Use the CSNA platform papers during your visit
- Use CSNA and strength of its membership to empower the message when using the approved positions of specific legislation
- Remember: Tell Your Story! How legislation affects constituents is important to the legislator! Give the member real stories and specific data to make your point.
- Just reach out and say hello!
- Take a picture!

After the Meeting:

- Send a thank you note recap your meeting
- Important Follow up with Chapter PP&L to make note of your visit
- Remember to document Send a picture!





Meeting Needs
