# Governor's Budget

Capitol Advisors, ACSA, CSBA and SSSA will team up to present the Budget Perspectives Workshop covering the Governor's January Budget proposal for 2014-15.

As the recent report from the Legislative Analyst's Office (LAO) highlights, California's economic recovery continues and state revenues have significantly exceeded projections for 2012-13 and 2013-14 while revenue growth over the next several years is also higher than previously projected. However, five years of sustained cuts means there will be heavy demands on new resources for stabilization and restoration in addition to the pressures and costs related to the LCAP and Common Core. The robust revenue growth will focus attention on the Prop. 98 minimum guarantee.

The Budget Perspectives Workshop will focus on the implications of the Governor's January 2014-15 budget proposal, which will also include proposed changes to 2013-14 funding levels. Because 2014 is an election year, all budget and policy proposals will be shaped by a heightened political dynamic that can be both good and bad for public education. Our team of experts is the best at reading the political tea leaves and will help local education leaders make the most informed decisions in the right political context.

We believe providing administrators, school board members, parents, teachers, and school employees with a concise and unbiased understanding of school finance with accurate political context is vital.
