Public Policy and Legislation

- What is Public Policy?
 - Public policy is a rule or regulation that is given to the public from the government. The policy is given to all the public and is for the entire public to abide by.


- What is legislation?
 - Legislations are laws enacted by a legislative body in a given place which are meant to be followed by the citizens.



- There is a lot of legislation that is written and implemented that can have significant impact on our programs, i.e. nutrition standards, food safety laws, etc.
- CSNA members contact their legislators to educate them about our programs and inform legislators we are the experts when it comes to school nutrition programs
- We want legislators to contact us when needing advice on issues that may impact our programs



- If legislation is in the process of becoming a law, we mobilize our CSNA members to contact their legislators and inform them of our position on pending legislation and reasons for our position
- Capitol Advisors Group (CAG) is the legislative advocacy group for CSNA
 - CAG maintains continuous contact with State legislators, legislative committees, education coalition partners
 - CAG educates these groups and legislative staff on our position on bills
 - We have a much better chance of the legislator supporting our position if we have allies on the issue

Scheduling a Cafeteria Site Visit

- CHECKLIST
- Identify your Legislator
- http://findyourrep.legislature.ca.gov,



- Contact Legislator's office and discuss the idea of a cafeteria visit with the appropriate staff person
- Identify potential dates and name of school for the site visit and include this information in your correspondence to the Legislator



- Purpose of event
- Potential Dates/Times
- - Your contact information (include e-mail, phone, fax numbers)
- Draft agenda for the site visit
- Include names of those who will also be participating (i.e. principal, superintendent, media/press, etc.)
- Thank the Legislator for their consideration of the request



 Notify your school district's Communication and Media Office as necessary



- Develop the agenda for the cafeteria site visit
- Review which meal will be served based on your menu and whether the Legislator will visit during breakfast or lunch
- Develop and compile "take away" packet of information for the Legislator



- **V** Identify "welcoming committee" to greet the Legislator.
 - Limit the committee to yourself and 3-4 other key school stakeholders and consider including a student on the committee.
- Invite key school stakeholders on the welcoming committee. This could vary by district, but may include the school superintendent and school principal.
- Reach out to local press and other media outlets and extend an invitation for them to cover the event



- Have a location already identified to snap a photograph of the Member with staff and children
- Conduct a "dry run" of the cafeteria visit and work out any kinks
- Reserve a room at your school to discuss issues and concerns with the Legislator



- Alert your school's front office that there will be a "special guest" arriving at the school
- Address all security issues for outside guests in advance (sign-in sheet, nametags, etc.)
- Issue a press release reporting on the visit, including basic background data given to the member or staff visitor



The Day of the Cafeteria Site Visit

- Assemble welcoming committee for the Legislator for "meet and greet" at a designated location of the school
- Conduct your cafeteria tour with your VIP's and enjoy a cafeteria meal with the children
- Adjourn to room for Q and A
- Thank all participants for attending and check them out at the front desk



After the Cafeteria Site Visit

- Send thank-you note to the Legislator, scheduler and staff person
- Send any follow up materials that were discussed during the site visit



Site Visit Agenda

- Remember, you're the school nutrition expert
- Be positive and focus on 3 or 4 key topics
- Tell your stories and how possible legislation they can influence will affect your program
- Showcase the healthy foods being served
- Their perception of school lunch is what they were served when they were in school


